

Project Completion Notice

CavityComplete® Wall System for Concrete Masonry Unit (CMU) with Masonry Veneer

To complete the process for the CavityComplete® Wall System for CMU with Masonry Veneer 10 Year Limited Material and Replacement Warranty, the project administrator must complete the following:

1. Submit a completed Project Profile at least two (2) weeks prior to beginning wall system construction, and receive a return acceptance
2. Submit a completed Project Completion Notice upon completion of work
3. Receive a written CavityComplete® Wall System for CMU with Masonry Veneer 10 Year Limited Material and Replacement Warranty

1. Completed Project Completion Notice form
2. Proof of CavityComplete® Components Purchase, Delivery and Installation. Acceptable proof shall:
 - a. Include documents that name the specific products identified in the Project Profile Form
 - b. Identify the distributor or seller of the products
 - c. Identify delivery to the project address with delivery date
 - d. Include items such as distributor invoices (pricing may be redacted), and/or bills of lading, or other job site paperwork that contains the required verifications for each component product
 - e. Be clearly legible

Project Completion Notice Submission Requirements

The following documentation constitutes the "Project Completion Notice". It must be submitted to the CavityComplete® Warranty Administration Center within three (3) months of substantial completion of the project in order to process and receive the actual warranty. The warranty is not in effect until the written CavityComplete® Wall System for CMU with Masonry Veneer 10 Year Limited Material and Replacement Warranty for the specific project is issued by the Cavity Complete® manufacturer group (the "CCMG"), consisting of Owens Corning Sales LLC, PROSOCO, Inc., Mortar Net Solutions, and Heckmann Building Products, Inc.

The CCMG will review the submitted documentation to verify that the CavityComplete® components approved in the Project Profile are certified by the submitter to have been purchased, delivered and installed on the subject project. Upon satisfactory verification, the CCMG will issue the Project Completion Notice the CavityComplete® Wall System for CMU with Masonry Veneer 10 Year Limited Material and Replacement Warranty.

NO WARRANTY WILL BE APPROVED/ISSUED IF THE PROJECT COMPLETION NOTICE IS SUBMITTED MORE THAN THREE (3) MONTHS AFTER SUBSTANTIAL COMPLETION OF THE PROJECT.
