



# STANDARD PRODUCT<sup>^</sup> LIMITED WARRANTY

## on Owens Corning<sup>®</sup> VentSure<sup>®</sup> Ventilation Products

### INTRODUCTION

Thank you for your recent purchase of Owens Corning<sup>®</sup> Roofing and Asphalt VentSure<sup>®</sup> ventilation products. We believe we manufacture the highest quality and most attractive ventilation product(s) available anywhere, and that is why we stand behind them with one of the best warranties in the industry. ### WHO IS COVERED

The property in which the products have been installed must be located in the United States or Canada, and you must be the original consumer purchaser (i.e., the homeowner, not the installer or contractor) (the "Purchaser") of one of our VentSure<sup>®</sup> ventilation products listed below, you are entitled to the benefits of this limited warranty.

### TRANSFERABILITY OF THE WARRANTY

This limited warranty is personal to original Purchaser and may not be transferred to any subsequent purchasers of the home.

### HOW LONG IS PURCHASER COVERED

The duration of Purchaser's limited warranty depends upon the type of VentSure<sup>®</sup> ventilation product(s) purchased. See the chart at the end of this limited warranty for the specific warranty period that applies to Purchaser's VentSure<sup>®</sup> ventilation product(s).

### WHAT IS COVERED

We warrant that Purchaser's VentSure<sup>®</sup> ventilation products are free from any manufacturing defects that materially affect their performance on the roof during the applicable warranty period.

### WHAT IS NOT COVERED

Damage to the product due to any cause not expressly covered herein. After our VentSure<sup>®</sup> ventilation products leave our manufacturing facility, they are subjected to conditions and handling beyond our control that could affect their performance. This limited warranty does not cover any problems with nondefective VentSure<sup>®</sup> ventilation products caused by conditions or handling beyond our control. Some examples of conditions not covered by this limited warranty include:

1. Acts of God, such as hail, strong storms or winds over the maximum windspeed listed in the chart at the end of this warranty, or ice damming above the area covered by leak barriers or above flashings.
2. Damage to or failure of the VentSure<sup>®</sup> ventilation products as a result of damage to or the failure of the underlying roofing structure.
3. Foot traffic on Purchaser's roof or damage caused by object(s) (i.e., tree branches) falling on purchaser's roof.
4. Improper or faulty installation of purchaser's VentSure<sup>®</sup> ventilation products – installation must be in accordance with our written installation instructions and comply with local building codes.
5. Inadequate ventilation or roof drainage. Some exceptions may apply. For questions, please contact us at 1-800-ROOFING.
6. Settlement of the structure or buckling or cracking of the deck over which purchaser's VentSure<sup>®</sup> ventilation products are installed.
7. Leaks caused by pre-existing conditions, structural failures(s) or damaged area(s) on or near the roof which are not part of the Roofing System such as chimneys that have loose or cracked mortar, skylight seams or soil pipe boots allowing water to enter the structure or Roofing System.
8. Damage to the VentSure<sup>®</sup> ventilation products caused by alterations made after completion of application, including structural changes, equipment installation, power washing, painting or the application of cleaning solutions, coatings or other modifications.
9. Improper storage, handling or other conditions beyond our control.
10. Damages caused by, or the cost to repair or replace, any non-Owens Corning<sup>®</sup> VentSure<sup>®</sup> ventilation products.
11. Improperly designed or installed gutter or downspout systems.
12. Any costs that purchaser incur which are not authorized in advance by Owens Corning.

### WHAT IS PURCHASER'S REMEDY

1. **Manufacturing Defects** – If during the warranty period there is a manufacturing defect in the product(s), we will provide Purchaser with replacement product or refund Purchaser the original purchase price (excluding labor), as reasonably determined at Owens Corning's discretion.
2. **Proration of Remedy** – If Purchaser's VentSure<sup>®</sup> ventilation product(s) carry a warranty of more than one (1) year and have been installed longer than one (1) year, we will take into account the number of full years of use Purchaser has enjoyed through the date of Purchaser's claim, and reduce the amount of our payment to Purchaser accordingly. That is, we will prorate the amount of payment though the date of claim for any manufacturing defects that cause leaks for the balance of the applicable warranty period. For example: If Purchaser has a 20-year warranty and Purchaser makes a claim in the 5th year of the warranty, we will pay Purchaser 75% of the VentSure<sup>®</sup> ventilation product(s) cost at time of purchase.

### REPLACEMENT PRODUCT VARIATIONS

As a result of our ongoing efforts to improve and enhance our product line, we must reserve the right to discontinue or modify our product, including their colors. We are not liable to Purchaser if Purchaser makes a warranty claim in the future and any replacement VentSure<sup>®</sup> ventilation product(s) Purchaser receives vary in color either because of normal weathering or changes in our VentSure<sup>®</sup> ventilation product line. Purchaser should understand that if we replace any of Purchaser's VentSure<sup>®</sup> ventilation product(s) under this limited warranty, we reserve the right to provide Purchaser with substitute VentSure<sup>®</sup> ventilation product(s) that are comparable only in quality and price to Purchaser's original VentSure<sup>®</sup> ventilation product(s).

### NO MODIFICATIONS TO THIS WARRANTY

This limited warranty may not be changed or modified. No one, including any representative or employee of Owens Corning and any representative or employee of a contractor or installer, has authority to assume any additional liability or responsibility for Owens Corning or in any way modify or change this limited warranty.

### CLAIMS PROCESS

To make a claim under this warranty, Purchaser needs to do so within thirty (30) days after Purchaser discovers the problem.. To fully evaluate claim, we may ask Purchaser to provide, at Purchaser's expense, pictures of the VentSure<sup>®</sup> ventilation product(s) samples for us to test.

### LIMITATIONS

THIS LIMITED WARRANTY IS EXCLUSIVE AND REPLACES ALL OTHER WARRANTIES, CONDITIONS, REPRESENTATIONS AND GUARANTEES, WHETHER EXPRESS OR IMPLIED, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, WHETHER BY STATUTE, AT LAW OR IN EQUITY AND IS LIMITED IN LENGTH TO THE EXPRESS WARRANTY PROVIDED ABOVE UNLESS A SHORTER PERIOD IS PERMITTED BY LAW.

THIS WRITTEN LIMITED WARRANTY IS PURCHASER'S EXCLUSIVE WARRANTY FROM OWENS CORNING AND REPRESENTS THE SOLE REMEDY TO ANY OWNER OF OWENS CORNING<sup>®</sup> VENTSURE<sup>®</sup> VENTILATION PRODUCT(S). OWENS CORNING MAKES NO OTHER REPRESENTATIONS, WARRANTIES OR GUARANTEES OF ANY KIND OTHER THAN THOSE STATED EXPLICITLY HEREIN.

PURCHASER'S REMEDY FOR DEFECTIVE OWENS CORNING® VENTSURE® VENTILATION PRODUCT(S) IS FULLY DESCRIBED IN THE PRECEDING SECTIONS, "HOW LONG IS PURCHASER COVERED" AND "WHAT IS PURCHASER'S REMEDY". PURCHASER IS NOT ENTITLED TO ANYTHING MORE THAN WHAT IS DESCRIBED IN THAT SECTION UNLESS OTHERWISE COVERED BY AN OPTIONAL OWENS CORNING® ENHANCED WARRANTY. WE ARE NOT RESPONSIBLE FOR ANY INCIDENTAL, CONSEQUENTIAL, SPECIAL, PUNITIVE OR OTHER DAMAGES OF ANY KIND INCLUDING DAMAGE TO PURCHASER'S STRUCTURE OR TO PURCHASER'S STRUCTURE'S CONTENTS WHETHER FOR BREACH OF THIS LIMITED WARRANTY, NEGLIGENCE, STRICT LIABILITY OR OTHER CLAIMS DERIVED IN TORT OR FOR ANY OTHER CAUSE.

Some states/provinces do not allow limitations on how long an implied warranty lasts and/or do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to Purchaser.
